Proprietor/Manager Recognition Award Application

The Proprietor/Manager Recognition Award annually recognizes an outstanding bowling center proprietor/manager for the enthusiastic support of national, state, and local bowling associations.

Eligibility...

- Eligible Nominees must be a current proprietor/manager of a USBC certified bowling center and be nominated by a local or state association.
- A *proprietor/manager* is defined as a person who is authorized to develop and implement bowling center policies and programs—regardless if the Nominee owns, manages, or serves as the General Manager of the bowling center.
- Local or state associations may nominate (or re-nominate) *one* award candidate per season.

Nomination Procedure...

- To nominate a candidate, complete this form and submit it for approval at the next local or state Board meeting.
- Include any addenda or items that help demonstrate the Nominee's merits.
- By **December 1st**, the completed form, reference letters, and any other material must be submitted to the NYS USBC members of the Awards Committee listed below.
- Applications are kept on file for *three (3)* years and may be updated annually. After *three* years, a *new* application must be submitted.
